A Protected Action Ballot will now be conducted by the Australian Electoral Commission to determine the level of support for the taking of specific industrial action. The ballot will be conducted by post.

WHO IS ELIGIBLE TO VOTE?

All employees of Toll Transport Pty Ltd T/A Customised Solutions Toll Global Logistics who are represented by the Transport Workers' Union of Australia in the negotiations of the proposed enterprise agreement.

WHEN WILL I RECEIVE BALLOT PAPERS?

- A postal vote pack will be mailed to your postal address on 21/12/2020.
- If you have not received your postal vote pack by 28/12/2020 please contact the AEC immediately for a replacement.
- How long do I have to cast my vote?
- The protected action ballot will close strictly at 10am Australian Eastern Daylight Time (AEDT) on 22/01/2021 and only ballot papers received by the Returning Officer by that time will be counted.

In support of reaching a union collective agreement with your employer, do you support the taking of protected industrial action against your employer which may involve taking separately, concurrently and/or consecutively, any or all the actions set out below:
